CONTRACT AGREEMENT

I (We) understand that, in order to be a Bar/Bat Mitzvah, my (our) child must have satisfactorily completed at least six (6) consecutive years of approved religious school training, beginning no later than second grade, and be attending the Religious School of Congregation Beth Chaim during the year of his/her Bar/Bat Mitzvah, (our fiscal year is from July 1 thru June 30) while meeting all standards set by Congregation Beth Chaim. I (We) understand that, in order to be a Confirmand, my (our) child must have satisfactorily completed at least nine (9) consecutive years of such training, while meeting all Congregation standards.

Further, I (we) shall be responsible for, and make timely payments of, all dues, fees and assessments required of members. It is further understood that, unless otherwise provided by prior written agreement with the financial secretary, (a) all billed items (including full year's dues) must be paid, in full, at least thirty (30) days prior to my (our) child's Bar/Bat Mitzvah and (b) the entire building fund must be paid in full at least thirty (30) days prior to the Bar/Bat Mitzvah of my (our) youngest child registered in religious school. In the event of my (our) resignation, I (we) understand that I (we) shall remain obligated to pay the balance of the full current year's dues, unless a special arrangement has been agreed upon by the Board of Trustees of Congregation Beth Chaim.

It is understood that all of the provisions and privileges of our membership shall be governed by the Constitution, By-Laws and Policies of **Congregation Beth Chaim**. In order for this application to be accepted, I (we) agree that we have fulfilled all financial obligations related to previous temple affiliations. My (Our) signature(s) below, along with this application, indicate my (our) agreement to these conditions.
